INSTRUCTIONS

Application for admission to the Pre-Licensure Program is a separate process. Applicants are responsible for being informed of the application criteria, admission requirements and policies posted in the Academic Catalog and Pre-Nursing Student Handbook.

Application Criteria

- 1. A minimum total cumulative GPA of 3.0.
- 2. Completion of Core pre-reqs with a minimum C.
- 3. International students from non-English speaking countries must demonstrate minimum English proficiency in one of the following ways:
- TOEFL iBT minimum score of 84 with a minimum speaking score of 26.
- TOEFL PBT minimum score of 560.
- IELTS overall score of 6.5 with a minimum 6.0 on all modules.

Application Procedures

Applicants are required to submit an application packet, complete the TEAS exam, and participate in an inperson group interview.

Application Forms & Documents

As part of the application packet, applicants are responsible for including all required information on the application forms and attaching the required documents. The application packet must be submitted to the School of Nursing Office in Wissink Hall 360 by the application deadline. Advisors will review submitted materials and may contact students with questions.

Application Deadline: Friday, February 7, 2025 at 12pm.

- Late applications or materials will not be accepted.
- Application materials may be mailed, but must be received by the February 7, 2025 deadline.

TEAS Exam Dates

Administered in-person by the University Testing Center

- Friday, January 10, 2025 12:00pm
- Saturday, January 11, 2025 10:00am
- Friday, January 17, 2025 12:00pm
- Saturday, January 18, 2025 10:00am

The TEAS must be complete by the application deadline.

TEAS Registration & Payment

Applicants are responsible for creating an ATI account, registering for the exam, and paying for the cost (\$97). Testing availability is <u>limited</u> for each test date. Applicants are encouraged to register early.

TEAS Accommodations

Students on file with Accessibility Resources should contact <u>TestingCenter@mnsu.edu</u> two weeks prior to the first January test date for arrangements. Published test dates does not guarantee accommodations are available for that session.

TEAS Score

Students testing on-campus do not need to submit a score report. Students may test in-person at another site then submit an official TEAS transcript, which must be received by the application deadline.

TEAS Delivery Method

The TEAS exam must be taken in-person. Online proctored exam scores will not be accepted. *EXCEPTION: Only online proctored TEAS exams, taken prior to July 1, 2024, will be accepted with valid scores.*

Applicants are responsible for being informed of all TEAS Exam policies. These policies, along with registration instructions and preparation information should be reviewed under the TEAS Exam subsection of the <u>Application & Admission</u> webpage.

Group Interview

Group interviews will take place between February 17-28. Applicants will receive an email Monday, February 10 around 12:00pm inviting them to sign up for a group interview date and time. Interviews are expected to last 30 minutes.

Admission Ranking

Each applicant will be rank-ordered using the Core Prerequisite GPA, the total TEAS score and group interview score.

- Core GPA is 50% of ranking.
- Total TEAS score is 25% of ranking.
- Group interview score is 25% of ranking.

The School of Nursing will admit the top 72 students from the rank-ordered applicant pool.

Admission Notification

Admission notifications are sent to applicants' university email address.

- Admission notifications will be emailed on Wednesday, March 12, 2025 between 3:00-4:30pm
- Admitted applicants are required to attend the Admission Advising session to be held on Friday, March 21, 2025. *Time TBD*

Admission

Full admission to the Pre-Licensure Program requires the completion of the following requirements prior to the program start date:

- Certification as a Nursing Assistant and listed as active on a Nursing Assistant Registry in the United States.
- Successful completion of the Support pre-requisites with a minimum C grade [BIOL 271, FCS 242, NURS 236, NURS 282, NURS 286, PSYC 101]
- Approval to work with patients without supervision from the Minnesota Department of Human Services Background check.

Additional information regarding these requirements will be provided to those admitted.

Pre-Licensure Program

The Pre-Licensure Program is approved by the Minnesota Board of Nursing and accredited by the Commission on Collegiate Nursing Education (CCNE). The program is comprised of 61 major core credits and leads to a Bachelor of Science Degree with a major in Nursing.

Projected Graduation: May 2027

Graduates of the Pre-Licensure Program are prepared to take the National Council Licensure Examination-Registered Nursing (NCLEX-RN). Successfully passing this exam permits the graduate to practice as a registered nurse (R.N.). Graduates with a Bachelor of Science Degree with a major in Nursing will have met the requirements for public health nurse certification and licensure as a school nurse in Minnesota.

ACADEMIC TRANSCRIPTS

Attach an unofficial transcript for each college where credit was taken and/or is currently in-progress.

- An unofficial transcript from Minnesota State University, Mankato must be included.
- Transcripts must be included in the application packet, even if previously submitted to the university.
- Unofficial transcripts from every college or university in the MinnState System are retrievable through E-Services under the Academic Records tab.
- For credits taken outside the MinnState System (University of Minnesota, private colleges, out of state colleges) applicants may need to request an unofficial transcript from their previous institutions if they did not retain personal copy.

DEGREE AUDIT

Attach a current Nursing Program, BS Degree Audit.

- Applicants are responsible for ensuring all coursework is transferred and listed on the Degree Audit.
- A printer friendly Degree Audit can be retrieved through E-Services. Students can also obtain a printed Degree Audit for free from the Campus Hub.
