## Application & Admission

Application for admission to the Pre-Licensure Program is a separate process, in addition to receiving admission to the University. Applicants are responsible for being informed of the application & admission requirements and the pre-nursing policies found in their Academic Catalog and the Pre-Nursing Student Handbook.

#### Application Criteria (Catalogs prior to 18-19)

- 1. Completion of 30 semester credits.
- 2. A minimum total cumulative GPA of 2.8.
- 3. Completion of required Core pre-requisites with minimum C grade.

#### Application Criteria (18-19 catalog to present)

- 1. Completion of 30 semester credits.
- 2. A minimum total cumulative GPA of 3.0.
- 3. Completion of required Core pre-requisites with minimum C grade.

#### **Application Procedures**

Applicants must submit the application forms with all required documents, complete the HESI Admission Assessment Exam, and participate in an on-campus group interview. Incomplete or late applications will not be reviewed.

#### **Application Form & Documents**

Applicants are responsible for including all required information on the application form and attaching all required documents. All materials must be submitted by 12:00pm on the application deadline: Friday, September 13, 2019.

Applicants should submit their materials to a nursing advisor during a walk-in appointment. Distant applicants may schedule a phone appointment, but documents must be mailed in advance and received by the deadline.

#### **HESI Admission Assessment Exam**

The HESI is a 4-hour computerized exam administered by the School of Nursing. Applicants are allowed 2 testing attempts each semester. An applicant's highest cumulative score is used towards admission.

#### **HESI Test Dates**

- Saturday, September 14: 11:00am 3:30pm
- Saturday, October 12: 11:00am 3:30pm

#### **HESI Payment & Registration**

Applicants are responsible for the cost of the exam (\$42) and must pay for each testing attempt. The HESI Payment and Registration instructions should be printed from:

#### **Group Interview**

Once the application deadline has passed, applicants will receive an email notification regarding the interview process, available dates, times and electronic sign up. Interviews will take place in October. Additional information can be found at:

#### **Admission Ranking**

Each applicant will be rank ordered using their Core Prerequisite GPA, the cumulative HESI exam score and the group interview score.

- Core GPA is 50% of ranking
- Cumulative HESI score is 25% of ranking
- Group interview score is 25% of ranking

The School of Nursing will admit the top 56 students from the rank ordered applicant pool.

#### **Admission Notification**

Admission notifications are sent to all applicants' email address listed on the Application Form.

- Admission notifications will be emailed on: <u>Wednesday, October 23, 2019.</u>
- Admitted applicants are required to attend a mandatory advising/orientation session on: <u>Thursday, October 31, 2019</u> from 4:00-5:30pm. Location TBD.

#### Admission

Full admission to the Pre-Licensure program requires the completion of the following requirements prior to program start date:

- Certification as a Nursing Assistant, and listed as active on a Nursing Assistant Registry in the United States.
- Completion of the Support pre-requisites with a minimum C grade.
- Approval to work with patients without supervision from the Minnesota Department of Health Background check.

Additional information regarding these requirements will be provided to those admitted.

#### **Pre-Licensure Program**

The Pre-Licensure Program is approved by the Minnesota Board of Nursing and accredited by the Commission on Collegiate Nursing Education (CCNE). The program is comprised of 59 major credits and leads to a Bachelor of Science Degree with a major in Nursing.

#### **Projected Graduation: December 2021**

Graduates of the Pre-Licensure Program are prepared to take the National Council Licensure Examination-Registered Nursing (NCLEX-RN). Successfully passing this exam permits the graduate to practice as a registered nurse (R.N.). Graduates with a Bachelor of Science Degree with a major in Nursing will have met the requirements for public health nurse certification and licensure as a school nurse in Minnesota.

- All information must be complete and correct to the best of your knowledge.

## **Academic Transcripts**

 <u>All</u> applicants must attach all academic transcripts, with the application. This includes transcripts from MNSU and all previously attended colleges/universities. Transcripts can be <u>official or</u> <u>unofficial</u>. Submitting your transcripts for admission to MNSU is a sperate process from submitting your transcripts to the School of Nursing.

## **Degree Audit Report (DARS)**

- <u>All</u> applicants must attach a current MNSU Nursing Degree Audit Report (DARS).
- The Nursing DARS report can be printed from E-Services or obtained from the Campus Hub.
- Applicants are responsible for ensuring all coursework from all post-secondary institutions have been transferred and evaluated by the Registration Office prior to application submission.
- If applicable, pre-requisite substitutions/waivers must be complete and noted on the DARS. A copy of the approved substitution/waiver is also acceptable.
- Applicants using a standardized exam score (AP, IB, CLEP) for a Core Pre-requisite must attach a copy of their score report, unless the score is noted on the DARS.
- Applicants who received approval of a Pre-Nursing Appeal, must attach a copy of the approval letter.

## **Nursing Assistant Verification**

- Applicants listed as active on a Nursing Assistant Registry in the U.S. may print and submit their verification from the online Registry system. It must include your name, certificate #, expiration date.
- Those without active certification at this time must provide verification prior to program admission.
